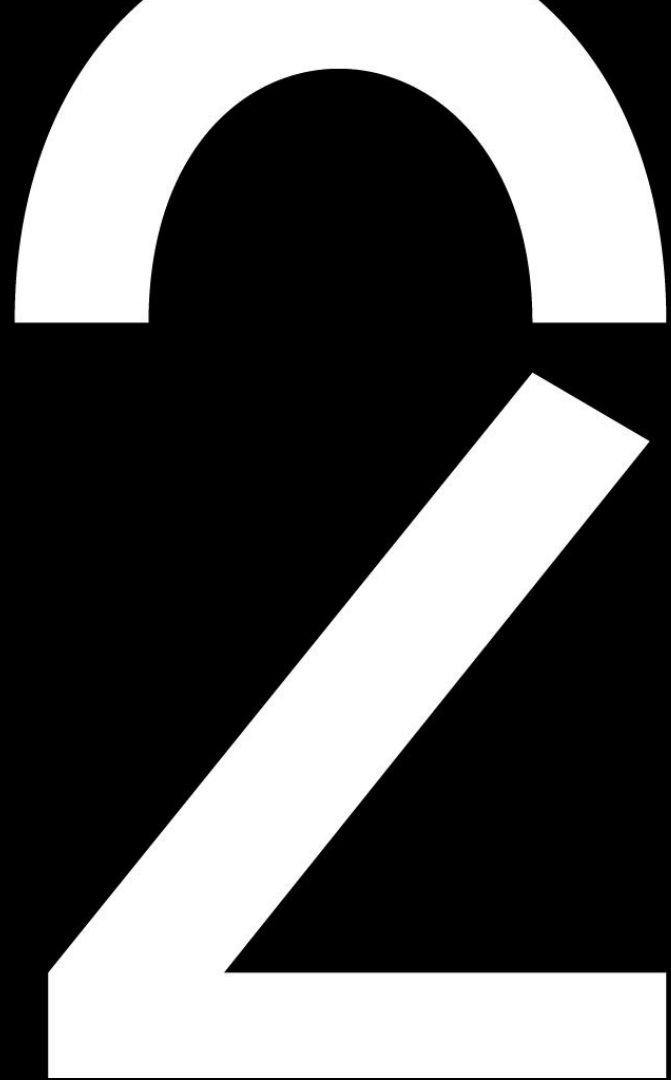

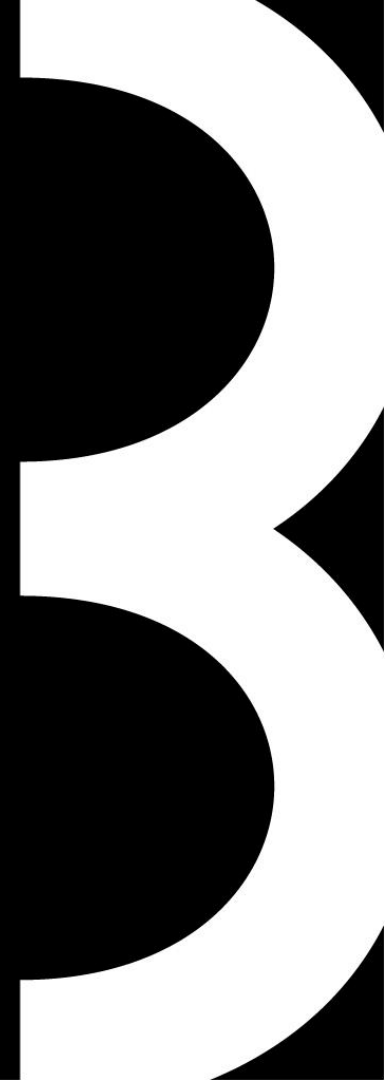
- Access to education is a constitutional right
- Regular residence is no condition for admission in higher education
- Federal law grants 'residence' permits for students
- Federal law allows people without necessary permit to be removed from the territory
- Provides the possibility of admission on the basis of an aptitude test.

- REGISTRATION
 - Contract student-institution of higher education
- FINANCING CONDITIONS
 - nationality

New admission procedures



New Admission procedures : guide Lines

04/05/2016

- Clear distinction between admission and registration, between language and diploma conditions
- Timing
- Paperless procedure
- Simplification : proof of a language level (B2 in the European qualification framework) instead of specific language certificates
- Credit contracts: students who don't have the necessary qualification can still register for a credit contract.

New admission procedure : process

04/05/2016

- All new students have to make an online registration
- Student administration will screen the online registrations
- Student are invited to enroll

- Admission office = back office for all questions concerning admission and registration
